



This 2019 Slip and Mooring Rental Agreement MUST be returned with payment and required paperwork no later than October 31, 2018.

I/We, the undersigned, do hereby agree to the following:

The North East River Yacht Club (NERYC) on behalf of NERYC DOCKS, LLC (100% owned by NERYC) shall furnish moorings and slips for rental by club members in good standing and who have paid their membership dues in full and have satisfied all other financial obligations owed the club.

The period of this agreement shall be from March 15, 2019 to November 30th, 2019. (Note: Water and pump out may not be available before April 1st, 2019 or after November 1st, 2018.) Slips will be available on or about March 15, 2019. Moorings will be available on or about April 15th, 2019 to about November 15th, 2019.

I/We have received a copy of the Docks & Moorings Policy and Procedures and will comply with guidelines outlined in the document. (Find this document on the www.neryc.com website under the "For Members" menu – "Documents". Full hyperlink: http://www.neryc.com/documents/waterfront/Docks_Moorings_Policy_Approved%207-18-14.pdf)

Dinghy rack space and motor storage rack space is available at no charge to mooring holders. Any disputes over dinghy space will be decided by the dock master. It is up to the member to label their dinghy space. Space permitting, other club members will be charged \$100 for a space on the dinghy rack which includes a space on the motor rack.

Slips will be provided with water from on or about April 1st, 2019 to approximately November 1st, 2019 weather dependent. Metered electrical connections will be available at each slip. Slip holders will be invoiced at the end of the slip rental season based upon usage with a \$10 minimum fee per slip (dock utility fee).

For any craft occupying a slip or mooring, members must provide proof of valid property or indemnity liability insurance in the amount of \$500,000 as specified by the Docks and Mooring Policies. Proof of said insurance must accompany this agreement. The insurance and registration must remain in force throughout the rental agreement period and members should forward any updated information to the club office within 2 weeks of expiration. Members will be held responsible for any damage they or their guest cause to the docks, dock fixtures, breakwaters, bulkheads, and moorings.

No member may occupy their slip or mooring without first having satisfied all financial and paper work requirements set by NERYC. Such financial requirements will include but not be limited to membership dues, capital improvement fee, assessments and other monies owed the club.

The pump-out system is available for use by all members at no charge. Pump out will be available from approximately April 1st, 2019 to about November 1st, 2019.

The member shall not hold NERYC and/or the Board of Governors and/or their agents responsible for any damage, acts of God, or loss of any type to his/her boat and/or contents and forever discharges the NERYC, the Board of Governors and/or its agents from all manner of action, causes of action, suits, debts, contracts, controversies, agreements, promises, variances, trespasses, judgments, executions, claims and demands whatsoever whether in law or equity against said NERYC while their vessel(s) and its contents have been placed with NERYC for dockage, mooring and/or storage or any other reason.

When vacating their slip/mooring for the winter, members are required to remove all lines, hoses, electrical cords, fenders and any other personal gear. They are also required to remove dinghies, motors and trailers from the club grounds. After December 1st 2019 the disposition of the above will be at the discretion of the NERYC dock master.

Members may occupy their slip throughout the winter of 2018/2019 only if they sign the winter slip agreement and pay for “winter in-water storage”. An electrical underwater “bubbler” fan will be placed in the slip they occupy and plugged in for ice “protection”. They will be billed an electrical usage fee for this service. There will be no exceptions. Liability insurance in the amount of \$500,000 must continue to be maintained as current. The Club must be provided with a renewed copy for any policy that expires during the period a vessel is in winter storage in an NERYC slip.

Members who are non-slip holders or mooring renters may store their boat for in-water winter storage in a vacant slip in the NERYC marina designated by the NERYC Dockmaster upon signing a Winter Storage Slip Rental Agreement and paying in full a \$500.00 fee to do so. The requirement to maintain the Club’s minimum liability insurance is the same as that of a regular slip holder.

Any boat occupying a slip or mooring after this end date of this agreement will be in violation of this agreement and subject to a daily charge of \$1/foot per of boat length per day until such vessel is removed from its slip or mooring.

SLIPS:

50% deposit required with return of contract by October 31st, 2018. This Slip Agreement must be completed and returned with a 50% deposit by October 31st, 2018 otherwise you may lose your slip!

Balance (50%) will be invoiced via e-mail by NERYC's office administrator and must be paid in full by January 31st, 2018.

Payments after this date will be subject to a monthly finance charge of \$25/month plus 1.5% per month for any unpaid balance. Payment with cash or check is preferred.

MOORINGS:

Full Payment required with return of this contract by October 31st, 2018.

Note: Proof of current liability insurance for at least \$500,000 must accompany this agreement.
