



2026 Slip and Mooring Rental Agreement

This 2026 Slip and Mooring Rental Agreement MUST be returned with payment and required paperwork no later than October 31st, 2025.

I/We, the undersigned, do hereby agree to the following:

The North East River Yacht Club (NERYC) shall furnish moorings and slips for rental by club members in good standing and who have paid their membership dues in full and have satisfied all other financial obligations owed the club.

The period of this agreement shall be from March 15th, 2026 to November 30th, 2026. (Note: Water and pump out may not be available before April 1st, 2026 or after November 1st, 2026.) Slips will be available on or about March 15th, 2026. Moorings will be available on or about April 15th, 2026 to about November 15th, 2026.

I/We have read a copy of the Docks & Moorings Policy and Procedures and will comply with guidelines outlined in the document. Please find this document on the www.neryc.com website at the following link:

Dinghy rack space and motor storage rack space is available at no charge to mooring holders. Any dispute over dinghy space will be decided by the dock master. It is up to the member to label their dinghy space. Space permitting and upon request, other club members will be charged \$138.00 for a space on the dinghy rack which includes a space on the motor rack.

Slips will be provided with water from on or about April 1st, 2026 to approximately November 1st, 2026 weather dependent.

Electrical connections will be available at each slip and subject to a dock utility fee. Slip holders will select their estimate usage category and apply this estimate to the annual slip fee total and pay upfront with their slip fee. The Dockmaster reserves the right to assess actual electric usage mid-season and make adjustments.

For any craft occupying a slip or mooring, members must provide proof of valid property or indemnity liability insurance in the amount of \$500,000 as specified by the Docks and Moorings Policies. Proof of said insurance must accompany this agreement. The insurance and registration must remain in force throughout the rental agreement period and members should forward any updated information to the club office within 2 weeks of expiration. Members will be held responsible for any damage that they or their guest(s) cause to the docks, docks fixtures, breakwaters, bulkheads and moorings.

No member may occupy their slip or mooring without first having satisfied all financial and paperwork requirements set by NERYC. Such financial requirements will include but not be limited to membership dues, capital improvement fee, assessments and other monies owed to the club.

The pump-out system is available for use by all members at no charge. Pump out will be available from approximately April 1st, 2026 to about November 1st, 2026.



No members shall hold NERYC and/or the Board of Governors and/or their agents responsible for any damage, acts of God, or loss of any type to his/her boat and/or contents and shall forever discharge the NERYC, the Board of Governors and/or its agents from all manner of action, causes of action, suits, debts, contracts, controversies, agreements, promises, variances, trespasses, judgments, executions, claims and demands whatsoever whether in law or equity against said NERYC while their vessel(s) and its contents have been placed with NERYC for dockage, mooring and/or storage or any other reason.

When vacating their slip/mooring for the winter, members are required to remove all lines, hoses, electrical cords, fenders and any other personal gear. They are also required to remove dinghies, motors and trailers from the club grounds. After December 1st, 2026 the disposition of the above will be at discretion of the NERYC dock master.

Members may occupy their slip throughout the winter of 2025/2026 only if they select the winter slip agreement option and pay for the "winter in-water storage". For ice protection, an underwater "bubbler" fan will be placed in the slip that they occupy. The winter slip fee will include an electric usage fee for this service. There will be no exceptions. Liability insurance in the amount of \$500,000 must continue to be maintained. The Club must be provided with a renewed copy of any policy that expires during the period that a vessel is in winter storage in a NERYC slip.

Members who are non-slip holders or mooring renters may store their boat for in-water winter storage in a vacant slip in the NERYC marina, as designated by the NERYC Dockmaster, upon signing a Winter Storage Slip Rental Agreement and paying in full a \$850.00 fee to do so, plus an electric fee of \$345 to account for a deicer for your boat. The requirement to maintain the Club's minimum liability insurance is the same as that of a regular slip holder.

Any boat occupying a slip or mooring after the end date of this agreement will be in violation of this agreement and subject to a daily charge of \$1.00/foot per boat length per day until such vessel is removed from its slip or mooring.

NERYC will not provide any refunds for cancellations of slips or moorings after December 31, 2025.
